Dear School Board Directors and Superintendent Banda:

The Washington Council on Public Legal Education (the Council) seeks to promote public understanding of the law and civic rights and responsibilities. The Council pursues this mission by conducting, coordinating, encouraging, and publicizing civic education efforts in Washington State.

Engaging young people to learn, discuss, and get involved with civic education projects in their early years has proven results: civically engaged citizens who contribute to their communities as adults. The potential benefits are particularly relevant for students who are identified as "at risk" because they come from low-income and less-educated households and often are denied access to robust civic education so important for their future engagement as citizens.

Young people lacking knowledge about civics are more distrustful of government, less apt to volunteer, and less likely to vote, according to a recent study by the Educational Testing Service. The authors¹ found a notable gap in the civic knowledge of students based on race and ethnicity. African-American and Hispanic students scored lower than white and Asian/Pacific Islander students in grades 4, 8 and 12.

In April, Seattle teacher Web Hutchins made a presentation to the Council and asked for the Council's support to his initiative, "Civics for All."² The principles contained in this initiative are ones that the Council is committed to, and we want to encourage you to support them as well.

Introducing young people in Seattle Public Schools to civic rights and responsibilities as they enter school and continuing to involve them in age-appropriate activities throughout their schooling is a wise investment in our community.

The goals of "Civics for All" affirm our belief in the importance of this endeavor, and we urge you to give it strong consideration.
